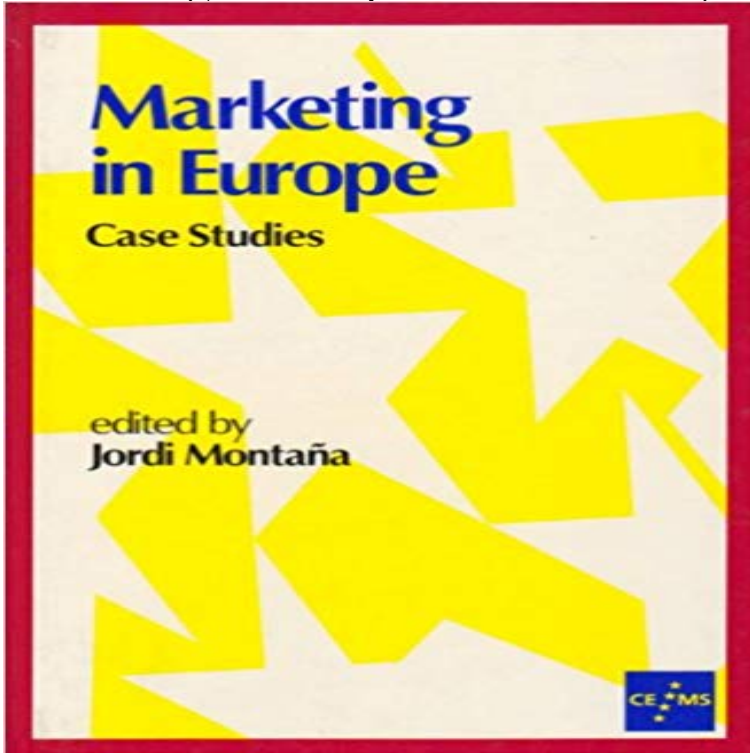


## Marketing in Europe: Case Studies (European Management series)
