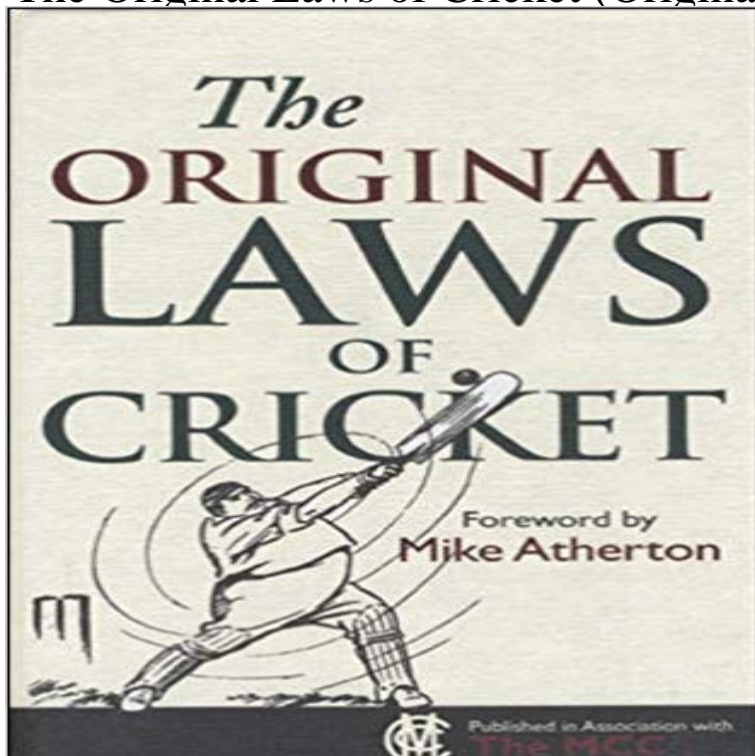


The Original Laws of Cricket (Original Rules)
