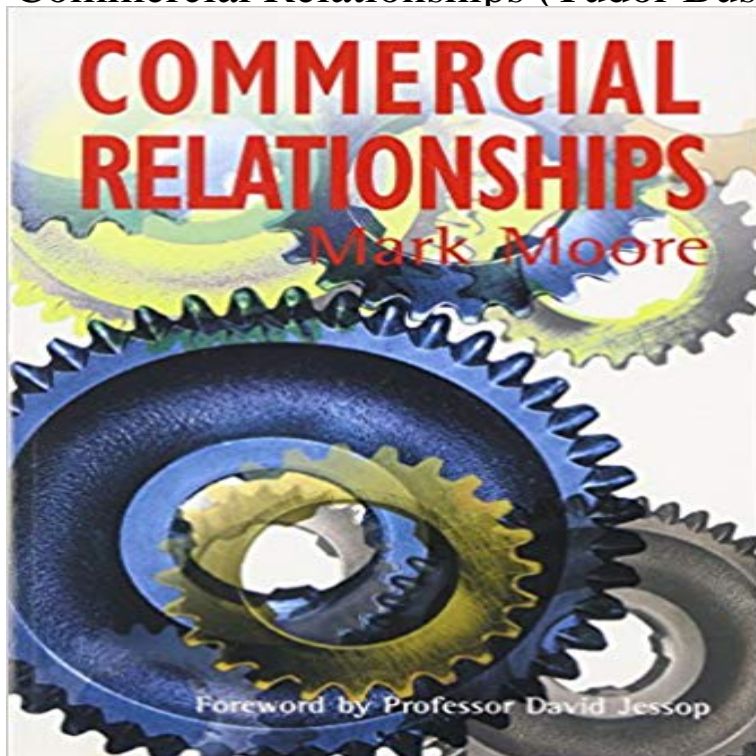


## Commercial Relationships (Tudor Business Publishing S)
