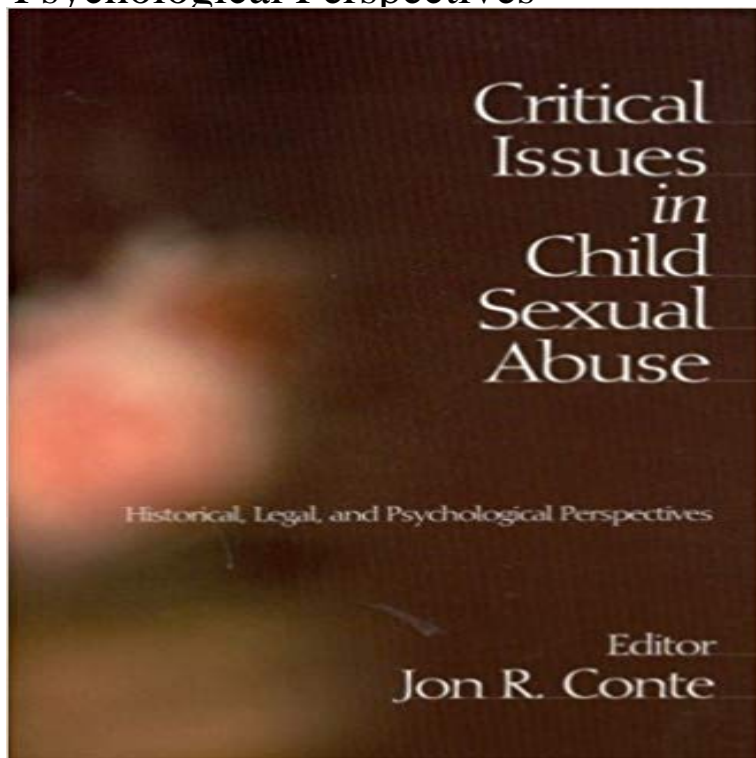


Critical Issues in Child Sexual Abuse: Historical, Legal, and Psychological Perspectives
