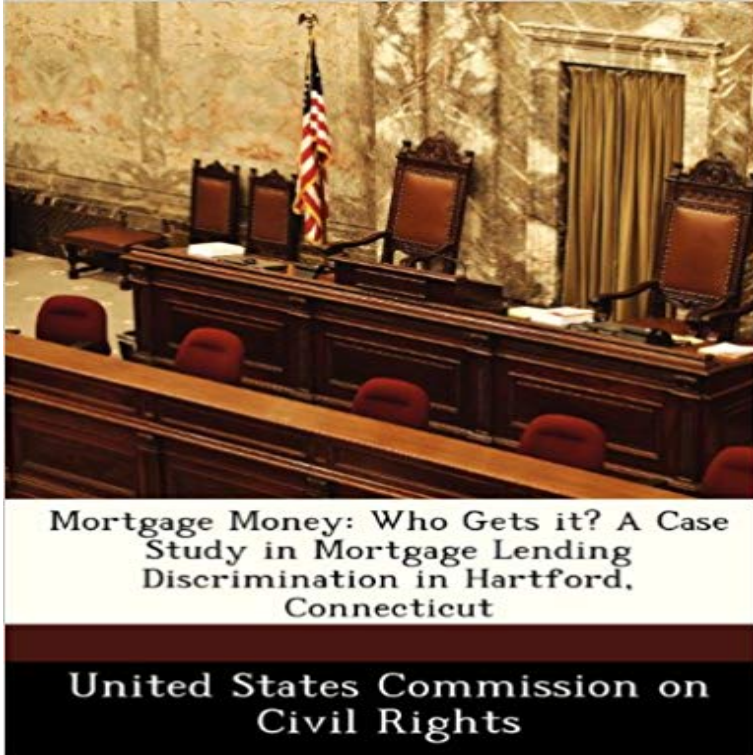


# Mortgage Money: Who Gets it? A Case Study in Mortgage Lending Discrimination in Hartford, Connecticut
